§ 2 Internship duration

- (1) The internship is carried out in the above-mentioned institution and can be completed full-time or part-time. The working hours during the traineeship in full-time will be approx. 40 hours per week. They will be fixed in accordance with the usual working hours of the institution providing the traineeship.
- The full-time internship comprises at least 10 weeks (approx. 390 working hours) and (2) can be divided into a maximum of two partial internships of at least 4 weeks (approx. 150 working hours). In the case of a part-time internship, the duration is extended accordingly. The traineeship will begin on and end on . (3) The traineeship lasts weeks and is carried out in Full time. § 5 Sickness and absence
